## Recognition of Human Sex and Labor Trafficking by Healthcare Professionals

**Presenter:** Dr. LaClaire Bouknight, Eaglevision CEO, Dream Center of Lansing. Chairperson of the Capital Area Anti-trafficking Alliance and a member of the Michigan Human Trafficking Task Force

### Presentation Summary:

This clear, concise and practical presentation includes the current legal definition of human sex and labor trafficking. It will explore demographics and risk factors of likely victims in the US and Michigan as well as the many needs of trafficking victims. This presentation includes the common ways victims present and where they likely intersect with our healthcare system. This discussion also includes the reporting requirements for health care professionals and resources for survivors in Mid-Michigan.

- Participants will recognize the signs and symptoms of labor and sex trafficking victimization
- Participants will know what are their reporting responsibilities in suspected cases of labor and sex trafficking for the state of Michigan
